Setup Fee

* Your base setup fee is \$95 and includes the following:

1. one web page (e.g. www.example.com/index.html)

Annual Fee

* Your base annual fee is \$50 and includes the following:

1. one domain name (e.g. www.example.com)
2. up to three email addresses (e.g. you@example.com)
3. up to four content updates

* You may purchase any of these items for an additional annual fee:

1. extra domain names (e.g. www.example.org) - \$15 per domain
2. extra content updates (use them or lose them; they expire after one year)

 - b. 48 content updates (+ 4 base = 52 total) - \$120

Negotiable Items

The rates listed above are for web pages whose content is already created. In other words, you already have a logo and slogan and just want the existing information placed on a web site. The published rates include website design services but not website content services.

The focus of Site Grill is to take your existing content (business cards, brochures, flyers, etc.) and assemble it into a website. I would be happy to work with you to create the website content you want, for a fee. Please contact me if you are interested in having me draw a logo, write the story of how you got into the business, etc.

I can setup dynamic items for your website, but the nature of these items does not lend them to a one-size-fits-all price. Please contact me for a custom quote for items such as animated graphics, sound, a product portfolio or catalog, a shopping cart for users to purchase items from your website, etc. I can also advertise your site on the internet. This means renting ad space on other websites. This is if you don't want your business to be just another search result.

Note 2: I will not be available to update content every day of the year, but it is possible to schedule updates in advance so that changes can occur daily. Please negotiate timing of updates with me if you desire daily updates.

Content

- * I reserve the right to reject any website or content that I deem inappropriate.
- * In general, keep things rated G.

Copyrights and Trademarks

- * I am not responsible for the legality of information or content that you provide.
- * You are responsible to ensure that items such as logos, slogans, photos, etc. do not violate any copyright, trademark, or other protections by being included on your website.
- * I may request documentation of permission to use items that appear to be copyrighted by a third party. I may refuse service if the documentation is not provided.

Domains

- * If you purchase additional domains, they will not have their own content. Rather, they will take the user to the main web site (the main or original domain).
- * If you want multiple websites with different content, each one will need to pay the normal setup fee.
- * If you have multiple websites, the annual fee is half the normal annual fee.

Purchase Timing

- * Additional items may be purchased at any time. You do not have to wait for your annual bill, although it would ease my record keeping to do so.

Advertising

- * I will not place any third-party ads on your site.

Links

- * I will place a link to this website on your website, unless the option to remove that link is purchased.
- * I may also place a link to your website on this website.

Page Size

* Some people may try to circumvent paying for extra web pages by placing too much content on just one page. To prevent that, I have a policy on the size of any given web page:

1. A web page must not exceed 500 words or images with areas totaling 1048576 pixels (1 MP).
2. A web page violating any measure will either
 - a. be split into as many pages as necessary to meet the measures (incurring cost for each page) OR
 - b. be kept whole but cost as much as if it had been split into multiple pages.

Updates

- * A content update is defined as one change to one page of a website.
- * Changing the same page multiple times counts as multiple content updates.
- * Items that are common across multiple pages, such as logos, contact information, titles, etc., incur cost for only page.

Cancellations

- * No refunds will be given for the setup fee.
- * If you cancel your website or do not renew by paying the annual fee, you forfeit the use of the domain name(s).
- * If you cancel before the annual fee is due, I will refund a portion of the annual fee. The portion is \$2 for each full month left in the annual agreement.

Spam

- * This section "Spam" does not apply if your email account is setup for forwarding only.
- * Your account may be terminated and your website forfeited if you use your email address to send spam.
- * You are responsible for any legal action or costs resulting from misuse of your email account.
